

## INGOT Financial Brokerage Ltd.

### Cashback Promotion Terms & Conditions

Cashback Promotion (the “Promotion”) Terms and Conditions are considered an addendum to and should be read together with the Financial Brokerage Agreement for the Account of Others in Foreign Stock Exchanges (the “Agreement”) between INGOT Financial Brokerage Ltd. (hereinafter “Company”, or “INGOT”) and the Client. Together with all the legal documents of INGOT Financial Brokerage Ltd., they form the totality of the agreement between both parties.

1. **Introduction:** This Promotion is a time-limited incentive offered by INGOT to its Clients with the purpose of encouraging continued trading activity.
2. **Duration:** The Promotion shall be valid as of February 10, 2026, until the end of the holy month of Ramadan for the year 2026.
3. **Eligibility Criteria:** New and existing Clients are offered the Promotion and can be eligible to participate, provided that their accounts have successfully been verified and have opened **Cashback account** type.
4. **Visibility & Activation:** The Promotion is offered to eligible Clients who shall receive a pop-up of this Promotion. Upon the electronic acceptance of the Promotion Terms and Conditions, it shall be considered as explicit approval to the Promotion and it shall be activated.
5. **Cashback & Withdrawal Terms**
  - a. Upon each closure of an eligible trading position by the Client, the applicable cashback amount (the “**Cashback Amount**”) shall be allocated to the Client’s trading account.
  - b. The allocated Cashback Amount shall form part of the Client’s available balance and may be withdrawn, subject to INGOT’s applicable withdrawal policy, AML/CFT requirements, account verification status, and applicable regulatory obligations.
  - c. All Cashback Amounts shall be allocated to the Client’s trading account in United States Dollars (USD), irrespective of the base currency of the Client’s account.
6. **Usage and Limits:** INGOT, at its sole and absolute discretion, reserves the right to impose, amend, or remove limits on the availability, frequency, value, and use of this Promotion at any time. Such limits may be determined based on various factors, including but not limited



to the Client's trading history, jurisdiction of residence, risk profile, or applicable regulatory requirements.

This Promotion applies exclusively for trading activity in specific financial instruments designated by INGOT from time to time (the “**Qualified Instruments**”). Cashback shall be issued by the Company solely on the basis of one (1) fully traded Standard Lot per Qualified Instrument, in accordance with the applicable cashback rates set out in the table below, and shall not be calculated, derived or inferred based on any other volume, trade size, transaction value, number of orders, or trading activity.

\* **Standard Lot means** the contract size defined by the Company for each instrument, as specified on the trading platform. Cashback is issued by the Company per one (1) fully closed standard lot (round-turn) on a Qualified Instrument only. Partial closures, multiple orders, or fragmented positions shall be aggregated solely for the purpose of completing one Standard Lot, and no cashback shall accrue or be payable unless and until one full Standard Lot has been completed.

**Metals and Future Metals are excluded from this Promotion.**

## 7. Disqualification:

**7.1.** A Client, trade, transaction, or any combination thereof shall be disqualified in any of the following events:

- a. Violation or breach of any of the Agreement terms or other legal documents.
- b. Being an employee at INGOT, its parent company, any subsidiary or affiliate thereof, or any of their respective officers, directors, shareholders, consultants, agents, service providers, or representatives, as well as any of their immediate family members (including spouses, parents, children, and siblings).
- c. If the Client opens, closes, or hedges any position within two (2) minutes, abusive trading practices, market manipulation, erroneous pricing, Client default, or trades



which INGOT suspects as an abuse of the trading environment executed by the Client.

- d. Engagement in any unacceptable trading practice, any form of market manipulation, or any act that does not comply with the Company's policies, terms, conditions, the Agreement, other legal documents, annexes, instructions, or internal policies issued thereunder, in accordance with applicable laws.

In such cases, the Company shall have the right, at its sole discretion and without any liability of any kind towards the Client, to take any action it deems appropriate to mitigate or prevent such behavior, including disqualification of any Client, trade, or transaction from participation in this Promotion.

- e. Trades made before the Promotion initiation or after the Promotion duration has ended.

**7.2.** Any disqualification of a Client, trade, or transaction under this Section shall result in the forfeiture, cancellation, and/ or reversal of any Cashback Amount already allocated, pending, or accrued in connection with such Client, trade, or transaction, without any liability on the part of the Company.

**7.3.** Where a Client, trade, or transaction is under review, investigation, or suspension, the Company shall have the right, at its sole discretion, to temporarily restrict, freeze, withhold, or suspend the use and/ or withdrawal of the Cashback Amount, in whole or in part, until such time as the Company is satisfied, acting reasonably and in accordance with applicable laws and applicable regulatory requirements, that the Cashback Amount is valid, compliant, and eligible to be released.

## 8. General Terms

- a. INGOT shall have the right, at its sole discretion and without prior notice, to alter, amend, suspend, cancel, extend, or terminate this Promotion at any time. Under no circumstance shall INGOT be liable for any consequences arising from such alterations, amendments, suspensions, cancellations, or terminations.
- b. If the Company suspects that a Participant has violated the rules of the Promotion and/ or has been identified to have engaged in abusive trading behavior in any way, then the Company shall have the right at any time and its sole discretion to immediately exclude the Participant from the Promotion and take additional actions in response to the abuse.



- c. If the account is cancelled, frozen, disabled, or terminated for any reason whatsoever after participation in the Promotion, the Company shall have the right to cancel the Client's participation in the Promotion, and such cancellation shall result in the automatic forfeiture of any entitlement to the Cashback Amount without prior notice. Such circumstances shall be deemed an express and final waiver by the Client of any right to the Cashback Amount.
- d. In no event shall the Company, its permanent and/ or contract employees, officers, consultants, agents, service providers, directors, shareholders, or system operators be liable to the Client and/ or any third party for any direct, indirect, special, or consequential loss or damage arising from or in connection with the Promotion.
- e. The Company shall not be liable for any loss or damage suffered by the Client due to his/her participation in the Promotion, disqualification, or otherwise. Moreover, the Company shall not be liable for any indirect, special, or consequential damages except as stated in our Agreement.
- f. The Company, its permanent and/ or contract employees, officers, consultants, agents, service providers, directors and shareholders, or system operators shall not be liable or responsible for any damages, losses, injuries, rights, claims, or actions of any kind in connection with the Promotion or resulting from participating in the Promotion and/ or the acceptance, possession, or use/ misuse of the Cashback Amount.
- g. The information contained herein is of a general nature only and does not consider your personal circumstances, financial situation, or needs. Before deciding to trade, please ensure you understand the risks involved and consider your level of experience. Trading and investing in global markets and foreign exchanges carry a high level of risk and can result in great losses; therefore, they may not be suitable for all individuals.
- h. This Promotion shall be governed by and construed in accordance with the laws governing the Agreement, and any disputes shall be resolved in accordance with the dispute resolution provisions set out therein.
